The intent of this notice is to identify potential offerors for market research purposes. The Naval Facilities Engineering Command (NAVFAC) Far East, PWD Sasebo, is currently seeking interested contractors who are both willing and qualified to provide to perform an Integrated Solid Waste Management including medical waste Collection and Disposal Services at Commander, Fleet Activities, Sasebo (CFAS), Japan.

The contractor must comply with Japan Environmental Governing Standards (JEGS) and local (Sasebo City and Saikai City) laws and regulations. This work will include Solid Waste, Industrial Waste and Medical Waste, as well as typical household and office wastes. The work shall be performed at various locations and could vary from location to location. Work locations include Main Base, Dry Dock #2, Main and Hario Housing Area, Nimitz Park, Akasaki, Iorizaki, Yokose, Maebata, Ammo storage areas in Maebata and Hario Shima.

The Government is contemplating issuing a Commercial solicitation in accordance with FAR Part 12.

The Government intends to issue the solicitation as an Invitation for Bid (IFB) in accordance with FAR 14.

The Government is contemplating a multiple year (one year base period and seven one-year option periods), single award Indefinite-Delivery Indefinite Quantity (IDIQ) type performance based service contract comprised of Recurring Work and Non-Recurring Work Items.
